નવી ટેરિફ ધમકીઓ અને નરમ એસિયન બજારો તેમ જ વિદેશી ફંડના આઉટફ્લોના કારણે શેરબજારો ગુરુવારે સતત ત્રીજા દિવસે ઘટ્યા હતા. રોકાણકારોનો સેન્ટિમેન્ટ નરમ રહ્યો હતો. ૩૦ શેરનો બીએસઇ સેન્સેક્સ ૨૦૩.૨૨ પોઇન્ટ કે ૦.૨૭ ટકા ઘટીને ૭૫,૭૩૫.૯૬ સેટલ થયો હતો. દિવસ દરમિયાન તે ૪૭૬.૧૭ પોઇન્ટ કે ૦.૬૨ ટકા ગગડીને ૭૫,૪૬૩.૦૧ થયો હતો.

એનએસઇ નિક્ટી ૧૮.૭૫ પોઇન્ટ કે ૦.૦૮ ટકા ઘટીને ૨૨,૮૧૩.૧૫ બંધ થયો હતો. ફુલ્લાઇન શેરો-એચડીએફસી બેંક અને આઇસીઆઇસીઆઇ બેંક શેરોમાં વેચવાલીથી પણ મુખ્ય ઇન્ફ્લોઇન્સ ઘટ્યા હતા. સેન્સેક્સ પેકમાંથી, એચડીએફસી બેંક, માસ્કિટ, ટેક મહિન્દ્રા, એચડીએલ ટેક, આઇટીસી, આઇસીઆઇસીઆઇ બેંક, કોટક મહિન્દ્રા બેંક અને બજાજ ફાયનાન્સ શેરમાં મોટો ભાવ ઘટાડો રહ્યો હતો.
